Qualifications

To qualify for the SSA Summer Internship, applicants must:

- Be currently enrolled as an undergraduate or graduate student at an accredited U.S. college or university.
- Have a minimum GPA of 3.0 on a 4.0 scale.
- Be studying a relevant field such as Public Administration, Social Work, Economics, Political Science, Business Administration, or a related discipline.
- Be a U.S. citizen or eligible to work in the United States.

Experience

Prior experience in volunteer work, community service, or previous internships in government or social services is preferred but not required. SSA values diverse experiences and perspectives.

Skills

Successful candidates should demonstrate:

- **Strong communication skills:** Ability to clearly convey information and assist in resolving customer inquiries effectively.
- **Research and analytical skills:** Proficiency in gathering and analyzing data, with a focus on detail and accuracy.
